



### A. Aims


1. To promote Musculoskeletal radiology as subspecialty of Radio-diagnosis.

1. The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the Memorandum of




Association and no portion thereof shall be paid to or transferred, directly or indirectly to the members of the society



- 5 To encourage research in Musculoskeletal radiology.


